ARTICLES OF INCORPORATION

We, the undersigned natural persons of the age of nineteen years or more, residing within the Fairbanks North Star Borough of the State of Alaska, acting as incorporators of a domestic nonprofit corporation, adopt the following Articles of Incorporation pursuant to the Alaska Nonprofit Corporation Act (AS 10.20):

ARTICLE I. The name of the corporation is Fairbanks Animal Shelter Fund.

ARTICLE II. The duration of the corporation shall be perpetual.

ARTICLE III. The purposes for which the corporation is organized are as follows:

- A. To operate exclusively for educational, scientific, and charitable purposes. The Fairbanks Animal Shelter Fund will serve the public interest by augmenting and supplementing services provided by the Fairbanks North Star Borough Animal Shelter and Division of Animal Control.
- B. To exercise all powers of corporations formed under the present or future Alaska State nonprofit corporation laws in order to accomplish the corporation's educational, scientific, and charitable purposes, including but not limited to the power to accept donations of money or property, whether real or personal, or any interest therein, wherever situated.

ARTICLE IV. The corporation shall be directed by a Board of Directors. Except for the initial Board of Directors, whose names are set forth in these Articles of Incorporation, the number and selection of the directors shall be as provided in the By-Laws of the corporation. The regulation of the corporation shall be governed by the By-Laws as adopted by the Board of Directors. The By-Laws shall comply with all applicable Federal and Alaska State laws and with these Articles of Incorporation.

A. The corporation shall not possess or exercise any power or authority, whether expressly, by interpretation, or by operation of law, that will or might prevent it at any time from qualifying and continuing to qualify as a corporation described in Section 501(c) (3) of the Internal Revenue Code of the United States (hereinafter the Code), and the Regulations established thereto, as they now exist or as they may hereafter by amendment, contributions to which are deductible under Section 170 of the Code. Nor shall the corporation engage directly or indirectly in any activity that might cause it the loss of status as an Alaska Nonprofit Corporation.

- B. At no time shall the corporation engage in activities that are unlawful under the laws of the State of Alaska, the United States, or any other jurisdiction where its activities are carried out.
- C. No solicitation of contributions to the corporation shall be made, and no gift, bequest, or devise to the corporation shall be accepted, upon any condition or limitation that in the opinion of the corporation may cause the corporation to lose its federal income tax exemption.
- D. Upon the termination, dissolution, liquidation, or winding up of the corporation in any manner and for any reason, voluntary or involuntary, its assets, if any, remaining after the payment or provision for payment of all liabilities of the corporation, shall be distributed to, and only to, one or more organizations for the humane treatment of animals selected by the Board of Directors and which organizations are described in Section 501(c) (3) of the Internal Revenue Code.
- E. The private property of the officers and directors of the corporation shall not be subject to payment of corporate debts to any extent whatsoever.

ARTICLE V.

- C. The name of the initial registered agent at the registered office is Ronnie Rosenberg.

ARTICLE VI.

The number of directors constituting the initial Board of Directors of the corporation is three (3). The names and addresses of the persons who are to serve on the initial Board of Directors are:
